Rethinking Gay Marriage | Part 06 | GOD'S Defense: Opening Statement

Our Sacred Men want us to believe that GOD condemns every act of same-sex intimacy without bias or looking at context (like intimacy between a loving, monogamous, and married couple). They claim Biblical Authority for their charge, therefore we will examine their 11 pieces of Biblical evidence from 4 witnesses. If two of the four witnesses successfully testify that GOD is not good or fair, then they will have proven their charge is true. If GOD is not Good or Fair, they will have successfully challenged our King Jesus' Throne and His right to be your King.

The Four witnesses are Moses, Jude, Paul, and Jesus. The Prosecution needs two of them to successfully witness that GOD isn't Good or Fair according to the Bible's rules on how to bring a charge against someone. These rules were established by Moses, and confirmed by Paul and Jesus. The one exception is Jesus since Father GOD always provides Himself as Jesus' second witness.

We are on an epic journey with mystery, intrigue, twists, and turns with our Good Shepherd. When He reveals new information to us, it is like a burning bush that invites us to turn aside and investigate.

One such burning bush, is Exodus International. Their mission was to convert same-sex attraction to opposite sex attraction through prayer and fasting. It dissolved with apologies from leadership to everyone they had harmed after 37 years of intense efforts by Christians that wanted to please GOD. If it had been about choice, then GOD would have rewarded some of them to encourage the others. Since they reported 100% failure, GOD communicated *LOUDLY* that it wasn't about choice to anyone with ears to hear.

The pile of evidence is building that GOD creates a percent of His animals samesex attracted with physical proof that they are different. This is another invitation for us to turn aside and ask our King Jesus what this means and how He wants us to respond.

There are two groups of people who engage in sex, USERS and GIVERS. When USERS treat others like sex toys for their own sexual gratification, GOD turns them over to their sexual wallow. This includes a downward spiral with numerous decision points to continue and numerous opportunities to stop. When they accept GOD'S invitation to stop, Holy Spirit is there to help them

begin their upward spiral as they learn to be a GIVER like Jesus. Every Christian success story of conversion from same-sex attraction to opposite-sex attraction comes from this group.

When a Jesus Follower uses sex to please their partner within a committed, monogamous relationship, they're already pleasing GOD so Holy Spirit doesn't help them reverse course.

When Sacred Men refuse to reassess their Biblical opinions when GOD presents them with evidence contradicting their theological positions, they become the Prosecution accusing GOD of being evil and unfair. This is unfortunate since our Good GOD loves His rainbow children even though His Sacred Men are demonstrating that they can't be bothered by GOD'S burning bushes. He wants His rainbow children loved and treated fairly and those that refuse will be turned over to their own theological wallow.

While any Expert Witness can claim to follow Holy Spirit, Jesus, or Father GOD, that assertion may not be true. When we follow our King Jesus, He is our Teacher. When we ask Jesus why, He conforms our mind to His as He explains His point of view. Since His Priorities are Loving GOD and Others as His Prime Directives, this is where He starts.

Therefore, this trial gives anyone the right to *voir dire* any expert witness to learn how their Biblical opinions hang on one or both of King Jesus' Prime Directives for any passage of Scripture they reference. This is mother's milk for baby Jesus followers and should be EZPZ for coaches that Jesus raised up to teach others His ways. If expert witnesses can't hang their Biblical opinions on either of King Jesus' Prime Directives to defend their Biblical opinions, their opinions are wrong. At best, they're irrelevant noise; at worst, they're doctrines of demons.

Jesus uses the Bible as a tool to teach us His ways, but following a created book and calling it by our King Jesus' Name isn't good for us. If the Bible is equal to King Jesus, then claiming Biblical authority will be equal to drawing upon King Jesus' authority which He has given us to trample on snakes and scorpions and to overcome all the power of the enemy; nothing will harm you. (- King Jesus in Luke 10:19 NIV)

The Prosecution's First Witness Is Moses:

Moses provides two pieces of evidence against GOD being Fair since Moses explicitly condemns men having sex with men while ignoring women having sex with other women.

The third piece of evidence is Adam & Eve's creation. GOD created everything including His Laws of deductive and inductive logic to help us follow Jesus' thought processes. When Moses and Jesus confirmed that GOD created a man and woman, that premise statement is TRUE. When the Prosecution claims that GOD *only* recognizes marriages between one man and one woman, it can be proven false with only one contrary example. When one premise is false, the Prosecution's whole piece of deductive evidence is false.

The fourth piece of evidence is Sodom and Gomorrah. This is an easy piece of evidence to dispute. Accusing GOD of condemn every gay man of being a gang rapist is inconsistent if GOD doesn't condemn every sacred man of being evil like Eli's sons or the High Priest at Jesus' trial.

The Prosecution's Second Witness Is Jude:

The Prosecution's fifth piece of evidence against GOD is Jude referring to the "strange flesh" at Sodom and Gomorrah.

The Prosecution's Third Witness Is Paul:

The Prosecution claims Paul provides 4 pieces of evidence against GOD being Good or Fair. Their sixth piece of evidence is the Greek word, *malakós*, we translate as 'homosexual.' Jesus testified preemptively 2,000 years ago that we've taken too much license with this translation and Father GOD is His Second Witness.

The Prosecution's 7th and 8th pieces of evidence refer directly back to Moses' law banning men having sex with men. If Moses' two pieces of evidence in Leviticus convinced you that GOD is unfair and not good, then Paul's use of the Greek word *arsenokoitēs*, provides you with your second witness to remove King Jesus from His Throne as your King.

The Prosecution's ninth piece of evidence provided by Paul is the only Biblical evidence that addresses women having sex with women. I will provide evidence that the men and women Paul is warning in Roman 1 are part of the USERS group who don't follow Jesus. As the only Biblical witness against women having sex with women, this changes the Prosecution's charge against GOD.

The Prosecution's Fourth Witness Is Jesus:

The Prosecution's tenth and eleventh pieces of evidence is Jesus giving His testimony that GOD created male and female to begin mankind. This evidence will be addressed with Moses' testimony about Creation. Here I will be providing my King Jesus' rebuttal to the Prosecution's charges. Our King Jesus will provide GOD'S Biblical testimony affirming same-sex marriages in the Old & New Testament. Jesus will also provide His personal, Biblical testimony that He does not condemn every act of same-sex intimacy without bias or looking at context. Father GOD, as He promised, will be our King Jesus' Second Witness.

CHANGING THE CHARGE AGAINST GOD

I submit to the Courts of Heaven that the Prosecution against GOD being Good or Fair to homosexuals lack two Biblical witnesses to support any charges against GOD being unfair to lesbians. Therefore, the Prosecution can only charge GOD for not being good or fair to gay men not homosexuals which would includes gay men and lesbian women.

With only one piece of evidence that even addresses women having sex with women, their charge against GOD being unfair to lesbians must be dropped. Without two Biblical witnesses to support this charge against GOD, they failed to reach the low Biblical threshold of being true with only two Biblical witnesses.

The Prosecution already believes that GOD is unfair and not good. To allow them to challenge our King Jesus' Throne, we must agree that GOD only condemns homosexual men and not women. This is a real problem for the prosecution because they are accusing GOD of being more unfair than most will affirm.
